Dear Colleague

Thank you for your interest in the Crystal Therapy Council (CTC).

CTC was formed in August 2011 with the following aims:

- To be a council and register for independent crystal healing or crystal therapy school which meets the training, assessment and management standards set by CTC.
- To set and maintain an agreed training standards of Crystal Healing /Therapy and to support efforts towards establishing a National Occupational Standard (NOS) in Crystal Healing/Therapy.
- To supply and work within an agreed Code of Conduct.
- To support registered schools through the sharing of expertise and providing verification and moderation for registered schools, where required.
- To support the provision of continuing professional development for tutors and practitioners .
- To act as a consultative body.

Membership Requirements

Anyone is welcome to join CTC but needs to show that they can meet the following requirements:

1. To agree to be bound by the CTC Constitution and Code of Conduct.
2. To agree to implement and abide by the CTC policy statements:
 - CTC Disciplinary Rules & Procedure
 - CTC Equal Opportunities Policy
 - CTC Grievance Procedure
 - CTC Harassment & Bullying Prevention Policy
 - CTC Fair Assessment Policy
 - CTC Policy for Disclosure of Criminal Records
 - CTC Environmental Policy

CTC Health & Safety Statement
CTC Voluntary Self Regulation

3. To show that the diploma course they offer is a (minimum) two-year course which meets the CTC Training Standards.
4. To show that they have adequate insurance cover
5. To show evidence of qualification as a crystal healer/therapist for at least 2 years if qualified with a CTC school or 5 years if qualified elsewhere.
6. To show evidence of teaching qualifications (minimum CTLLS or the equivalent) or evidence of teaching crystal healing/therapy for more than seven years. PTLLS is considered with evidence of teaching for more than three years.
7. To show evidence of good practice in teaching, assessment and verification of student's work and to engage with one of the CTC verifiers/moderators if there are any queries
9. To be willing to join in any standardisation exercise run by CTC

The fees for joining CTC are as follows:

1. On application – a fee of £200.

(CTC is not an accreditation or assessment body, but it must check that CTC requirements are met to admit a school onto the CTC Register)

Annual Membership

This is £20-25 per annum, but is subject to annual review.
